

## Privacy Policy

The terms "We" / "Us" / "Our"/"Company" "GETINTOFILMS.COM" individually and collectively refer to **GETINTOFILMS** and the terms "You" /"Your" / "Yourself" refer to the users.

This Privacy Policy is an electronic record in the form of an electronic contract formed under the information Technology Act, 2000 and the rules made thereunder and the amended provisions pertaining to electronic documents / records in various statutes as amended by the information Technology Act, 2000. This Privacy Policy does not require any physical, electronic or digital signature.

We also ensure that these recipients of such information agree to process such information based on our instructions and in compliance with this Privacy Policy and any other appropriate confidentiality and security measures.
- (c) The personal information of candidates who register under 'candidate/ actor's' tab, will be disclosed to the movie directors / movie makers/ ad film makers/ serial makers/ documentary makers/ casting directors / casting agencies or anybody who is on the lookout for actors / actresses for their projects,, to facilitate to get the aspiring candidates a call for audition or an acting roll in their projects.
- (c) The personal information of candidates who register under 'other talents' tab, will be disclosed to the movie directors / movie makers/ ad film makers/ serial makers/ documentary makers/ casting directors / casting agencies or anybody who is on the lookout for technicians or any other talents other than actors and actresses for their projects to facilitate to get the aspiring candidates an opportunity to work in their projects.
- (d) The personal information of directors who register under 'directors' tab, will be disclosed to the actors/ actresses / aspiring actors / aspiring actresses who has registered under 'candidate/ actor's' tab, and to the candidates who has registered under "other talent' tab, by thus enabling them to contact or to apply for the projects for which the artists or technicians are sought for by the directors.

### **INFORMATION SECURITY**

We take appropriate security measures to protect against unauthorized access to or unauthorized alteration, disclosure or destruction of data. These include internal reviews of our data collection, storage and processing practices and security measures, including appropriate encryption and physical security measures to guard against unauthorized access to systems where we store personal data.
